


### Minister, **MoHUA** addresses **SVANidhi Questions in Parliament Winter Session**

### Swati Santosh Kadam: A Beacon of Hope Amid Adversity

In the heart of Kolhapur, Maharashtra lives a remarkable woman named Swati Santosh Kadam. Swati's journey is driven by a dream called "Welcome Rolls Point". In 2020, as the COVID-19 pandemic led to nationwide lockdowns, Swati's "Welcome Rolls Point" business was stagnant, and her husband's job as a private travel company driver faced challenges. Swati was listening to a local radio station at home when she heard an advertisement about the PM SVANidhi scheme. Swati applied for a loan and secured her first loan of Rs 10,000 in December 2020. With this boost, she reignited her "Welcome Rolls Point" business. After repaying her initial loan, she applied for a second loan of Rs. 20,000 in January 2022. This support further fueled her business ambitions. Swati's unwavering dedication paid off, and she was applying for her third loan, a substantial Rs. 50,000, in January 2023.
